



## VCC Family Resource: Benefits, Taxes & Accommodation Information

This resource sheet is intended to support residents and families with general information regarding benefits, taxes, and accommodation fee resources.

### Common Benefits and Income Supports

- **Canada Pension Plan (CPP):** Government pension benefit information available through Canada.ca, see [link](#).
- **Old Age Security (OAS):** Monthly pension payments for eligible seniors, see [link](#).
- **Guaranteed Income Supplement (GIS):** Additional monthly payments for eligible low-income seniors receiving OAS, see [link](#).
- **Alberta Seniors Benefit (ASB):** Monthly financial assistance for eligible low-income Alberta seniors, see [link](#).
- **Supplementary Accommodation Benefit (SAB):** Financial assistance for eligible low-income residents in continuing care, see [link](#).
- **AISH:** Financial and health benefits for eligible Albertans with permanent medical conditions, see [link](#).
- **Canadian Dental Care Plan (CDCP):** Dental coverage for eligible Canadian residents who do not have access to private dental insurance. Coverage may assist with dental exams, cleanings, fillings, and other eligible dental services, see [link](#).

Families with specific questions regarding benefits or eligibility are encouraged to contact the Social Worker directly, as each resident's circumstances may differ.

### Tax Receipts and Accommodation Fees

- Venta Care Centre provides a Summary of Accommodation Charges for tax purposes.
- Long-term care accommodation fees may be reported on line 33099 under eligible medical expenses, depending on individual circumstances.

- Venta Care Centre is unable to provide a breakdown of accommodation fees into separate service categories such as nursing care, housekeeping, meals, or wages.

Families are encouraged to consult the CRA or a tax professional regarding medical expense claims, Disability Tax Credit questions, or tax eligibility.
